WHEREAS VJSS is a private NGO working for Wildlife Conservation, Rescue and documentation

AND WHEREAS MVP's K.R.T. Arts, B.H. Commerce and A.M. Science (KTHM) College Nashik provides education and research in various areas of Technology, Science, Humanities and Social Sciences, etc. and is recognized by Savitribai Phule Pune University, Pune.

1. Objectives of MoU:

- a. To promote interaction between VJSS and KTHM College in mutually beneficial areas.

- c. To educate students about wildlife conservation, globally threatened species, and wildlife rescue.

- c. Organization of programs for students and faculty on the occasion of dedicated days and weeks as per international and National days for Wildlife Conservation and species awareness.
- d. Work on biodiversity conservation projects with the involvement of expertise from both members.
- e. Provide internships for the students on various projects related to wildlife documentation and conservation.

Both VJSS and KTHM College agree to hold in confidence all information/data created during the performance of the MOU and will not disclose the same to any third party without written consent.

Duration of MoU:

This MoU, unless extended by mutual written consent of the college and VJSS, shall expire until expressly terminated with mutual consensus after the effective date specified in the opening paragraph.


