OBJECTIVES OF MOU:

The general objectives of this MOU are to estimate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the intellectual life and skill development on both campuses, and to contribute to increased cooperation for the Nation building. Thus, Vidyottama Foundation Nashik and KTHM college Nashik have agreed in support of their mutual interests in the field of, social, cultural, education and skill development.

1.The two institutions will:



- a) Cooperate in the exchange of information related to their activities in teaching-learning developments in the fields of mutual interests.
- b) Promote appropriate joint projects with particular emphasis on student's skill development.
- c) Endeavour to encourage students and staff to be an active participants in Nation building.
- d) Conduct short courses, as mutually agreed in writing between the parties prior to commencement of this activity.
- e) Conduct industrial-academic projects, as mutually agreed in writing between the parties prior to commencement of this activity.
- f) Prepare litratural, social and cultural development projects, as mutually agreed in writing between the parties prior to the commencement of this activity.

2. The aim of the (MOU) shall be to achieve a balance in the prospective contributions and benefits of the collaborative, and this shall be subject to periodic review by both the parties.

NOW IT'S AGREED as follows:

1. MUTUAL COOPERATION

- The partnership will be conducted in a spirit of mutual benefits and fairness and the parties agree that they will use their utmost goodwill and reasonable efforts to fulfil their respective obligations set out herein.
- The infrastructure, procuring equipment will be borne by both parties themselves in their institutions.

2. TERMS & CONDITIONS:

Both Parties will have to follow below mentioned terms & conditions:-

Party I and II in collaboration will organize training programs wherever required for imparting necessary skills to students either at the site of Party I or Party II.

This MOU may be amended, renewed & terminated by mutual written agreement.

3. FINANCE

Initially, the programs will be finalized based on knowledge sharing without any financial commitments.

4. DURATION AND TERMINATION of



This MOU is effective upon the date it is executed by the duly authorized representatives of the parties to this MOU, for a term of five years (60 months) and shall terminate upon the completion of the agreed terms.

Each Partner shall have the right to terminate this Agreement at any time if it determines that in its opinion, reasonably held, the other Partner has failed to honour its obligations arising from this MOU in a material manner.

5.CONFIDENTIALITY

Except as required by law, each Party is obliged not to disclose any confidential or proprietary information concerning the other Party, its partner entities and its activities so that the interests of each Party will not be damaged. Confidential information consists of all in formations that is not, otherwise, readily available to the public.




