Memorandum of Understanding

This Memorandum of Understanding (MoU) is made and entered into on this 20th December 2019

by and between

KTHM College, Gangapur Road, Nashik - 422 002 (which expression shall, unless it be repugnant to the context or meaning thereof, mean and includes their heirs, executors, administrators and assigns), represented by its Principal (hereinafter referred to as 'KTHM'), party of FIRST PART

AND

IndiaFIRST Robotics Innovation and Research LLP, having its office located at IndiaFIRST-Fourtech House, Plot NO 4, Behind Mr Veg Restaurant, Parihar Chowk, Aundh, Pune - 411 007 (which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successor and assigns), represented by its Director, (hereinafter referred to as 'IFR'), party of the SECOND PART.

1. Scope of the memorandum:

This memorandum sets forth the ground for collaboration / educational partnership between KTHM and IFR as Industry Partner for IIC-MHRD and for offering and conducting training programs on Robotics & Industrial Automation as a central facility in the area of Electronics, Electronics & Communication, Computer Science, Information Technology & Embedded Technology for providing training to the students of KTHM and offer certificate jointly signed by KTHM and IFR.

2. Responsibilities of the KTHM and IFR

The KTHM will make arrangement for classroom, teaching material, 2.1 computer lab, internet connection and teaching aids like projector, white board, markers etc. The KTHM and IFR jointly fulfill the required training equipment / instruments for conduction of proposed courses. This activity will utilize the lab equipment's / instruments for skill enhancement and capacity building of students.

2.1.1 The IFR will design curriculum & training programs as listed in Annexure-I and the financials are as mentioned in Annexure-II.

2.2 The KTHM can display the IFR training program advertisements, give training program advertisement in electronic media that will be provided by IFR on their websites that will help promote the training programs.

2.3 The KTHM have to do joint branding of IFR training programs for which KTHM will have to put up posters on Notice board, TPO office, Canteen, Library notice board, Auditorium and at least one banner in

an area of campus that has visibility.

2.4 The KTHM can include details of the IFR training programs in their curriculum, but teaching, training, assessment, course evaluation and participation certification will be done jointly by KTHM & IFR.

2.5 IFR will depute one person for administration and send trainers to conduct regular and special training program. The timing for which will be decided mutually for conducting regular batch(s). The trainer can also be sent for weekend and corporate batches.

2.6 The financial modalities mentioned in Annexure-II may be discussed

or amended by concerned authorities of KTHM and IFR.

3. General

3.1 Confidentiality – Both parties agree to strictly maintain the confidentiality of all information disclosed to it by the other party and to use such information only in connection with the legitimate purposes of implementing this MoU.

3.2 Effective Date - This MoU is effective from the date of signing by

both the parties.

3.3 Validity – This MoU is valid for an initial period of 5 years and may be renewed for further period with mutual consent of both the parties.

3.4 Termination – This MoU may be terminated by either party without assigning reasons thereof by giving the other party a written notice of its intention to terminate the agreement minimum 2 months in advance of the intended date of termination.

Principal KTHM and Director IFR will be or the person nominated by them will be Program Coordinator for the proposed training programs. The above MoU is being approved by **Principal KTHM** and **Director IFR**, **Pune**.

If any issue arises on the said terms and conditions, the final decision should be taken by Principal KTHM & Director IFR.
