(First Party and Second Party are hereinafter jointly referred to as 'Parties')

WHEREAS the Parties are desirous of entering into Collaboration to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms contained herein:

1. PURPOSE

The Purpose of this Collaboration (hereinafter called the 'COLLAB') is that the two Parties will take up various educational activities and exchange of knowledge based on mutual cooperation and understanding.

2. AREAS OF CO-OPERATION

Both the Parties after due considerations of various aspects have arrived at the following understanding in respect of dissemination of academic knowledge and participation in various educational programmes:

- 2.1 Both the parties believe that cooperation between the two would be a major benefit to the student community to enhance their knowledge and Skills.
- 2.2. Both the Parties hereby agree to collaborate and provide assistance to the other party for successful completion of different activities such as Enhancing Communication Skills, Educational Webinars, Guest Lectures, Production of Instructional Materials, Teacher Training etc.
- 2.3. All collaborative activities will focus on dissemination of knowledge and sharing of Resource persons. Both the parties will train the students on communication skills in English in order to bridge the gap in skills and make them ready to face the future challenges.

- 2.4. The parties will evolve a mechanism for exchange of experiences and expertise for mutual benefits
- 2.5. Both the parties will actively engage to help the delivery of On Job Training and Internship to Students.
- 2.6. Both the parties will extend necessary support to organize Guest Lectures for the students
- 2.7. The Parties are hereby agreed to establish mutual association on the aforesaid areas.

3. FINANCIAL ARRANGEMENTS:

This COLLAB will not commit any financial obligation by one Party to the other. Each party will bear its own cost and expenses in the implementation of activities under this COLLAB

4. EFFECT OF THE COLLAB: This COLLAB serves only as a record of the Parties' intentions and does not constitute and is not intended to constitute or create obligation under domestic or international laws and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations expressed or implied.

5. ENTRY INTO EFFECT AND DURATION:

This COLLAB will come into effect on the date of signing and will remain in effect for a period of two years. This COLLAB may be extended for a further period as may be agreed in writing by the parties. However, the Agreement may be terminated before the expiry of the period of two years by six months' notice in writing delivered by any party to the other.

This COLLAB shall be construed with a purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this COLLAB shall create any legal relationship between the Parties.
