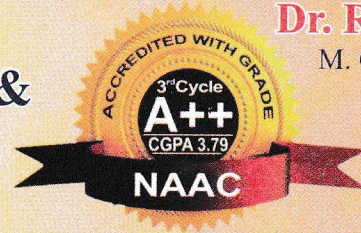

Dr. Jayant Dhake is a Psychiatrist in Nashik. He is work with Dr. Jayant Dhakes Rhythm Centre for Psychological Health in Ashok Stamp, Nashik. Dr. Jayant is experienced & skilled his field of specialization. They provide services for the following categories: Psychotherapy, Clinical Psychologist, Cognitive Behaviour Therapy, Behaviour Therapy, Spiritual Healing Services, and Suicidal Problem.

The parties are desirous of entering into this Memorandum of Understanding (MOU) to facilitate implementation of the partnership and for related purposes upon the terms and conditions hereinafter contained.

## CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within **The Department of Psychology, The Department of Psychology, KRT Arts, BH Commerce & AM Science (KTHM) College Nashik** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind promoting overall well-being among the affected children, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.



## CLAUSE 2

### SCOPE OF THE MoU

The Memorandum of Understanding likely outlines collaborative efforts between the **The Department of Psychology, KRT Arts, BH Commerce & AM Science (KTHM) College, Nashik and Dr. Jayant Dhake, Psychiatrist, Head, Rhythm-Center for Psychological Health, Nashik. Ganga Apartments, Near Ashok Stambha, Nashik, 422001, Maharashtra.** Promoting more effective encompassing mental health issues, counselling skills, therapeutic Knowledge, and educational initiatives. And to also acquire professional skills in relation to mental illness and treatment.

The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfilment of the purpose of the MoU.

It is not the intent of this MoU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.

Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.

There is no financial commitment on the part of **The Department of Psychology, K.R.T. Arts, B.H. Commerce & A.M. Science (KTHM) College, Nashik**, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

The Scope/ Objective of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

1. Creating awareness about difference between normal and abnormal behaviour
2. To enhance the skill of Counselling with practical knowledge
3. To diagnose mental disorder and learn about line of treatment of mental disorders.
4. To develop appropriate skills of counsellor and psychotherapist to practice evidence-based psychiatry
5. Student be aware of the legal issues in the practise of Psychiatry
6. Identify the social, economic, biological and emotional determinants of mental Health
7. To engage student in training programme directed by Savitribai Phule Pune University Pune.
8. To permit and aware Undergraduate and Post Graduate levels student for limited periods of time for purpose of case study and /or on the job training.





9. To jointly organize seminars, conferences, and workshops on mental health and various psychological issues.

10. Promoting such other activities/programs as mutually agreed from time to time.

Both party's further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, and person(s) responsible for its implementation, etc.

### CLAUSE 3

#### INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### CLAUSE 4

#### VALIDITY

4.1 This Agreement will be valid for 12.02.2024 to 11.02.2029 or until it is expressly terminated by either Party on mutually agreed terms, during which period **Dr. Jayant Dhake, Psychiatrist, Head, Rhythm- Center for Psychological Health, Nashik. Ganga Apartments, Near Ashok Stambha, Nashik, 422001 , Maharashtra** the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of **Dr. Jayant Dhake, Psychiatrist, Head, Rhythm- Center for Psychological Health, Nashik. Ganga Apartments, Near Ashok Stambha, Nashik, 422001, Maharashtra**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU.

4.2 Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

### CLAUSE 5

#### RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **The Department of Psychology, KRT Arts, BH Commerce & AM Science (KTHM) College Nashik** and **Dr. Jayant Dhake, Psychiatrist, Head, Rhythm-Center for Psychological Health, Nashik. Ganga Apartments, Near Ashok**



**Stambha, Nashik,422001 , Maharashtra.** is acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Nashik.
