


## ARTICLE-II: TERMS OF INTERACTIONS


Both K.R.T. Arts, B.H.Commerce and A. M. Science College, Nashik and BRC shall encourage interactions between the students and faculty of K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik and Research fellows, Researchers and industrialist associated with BRC through the following arrangements:

1. It is a non-profit, non-religious and non-political interaction.
2. Organization of joint seminars at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik.
3. Laboratory as well practical training of K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik students at BRC.
4. Joint guidance for student projects at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik by BRC on mutually agreeable terms.
5. BRC would accommodate Science students who have completed the Degree course successfully in such a way that BRC deems convenient to it for the purpose of industrial training.
6. BRC may depute its personnel as visiting faculty at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik to teach any of the specialized topics on mutually agreeable terms.
7. BRC personnel, as well as research scholars, may also be allowed to enroll for their Research at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik, subject to availability of seats, research facilities and subject to their fulfilling eligibility criteria and all other academic regulations of K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik. Further, BRC may request to design and teach a Course or Courses which it deems fit to enhance quality and performance of students. Such Courses maybe run at any mutually convenient premises.
8. BRC may seek assistance / guidance of K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik faculty members in product / process modification, modernization, research, trouble shooting etc. through students so as to improve their intellect.
9. BRC will arrange the industrial visits of students to provide them with an exposure to various equipment, instrument etc.
10. BRC may showcase its business activities at the seminar / workshop / conference etc. at K.R.T.Arts, B.H.Commerce and A. M. Science College,


11. BRC may avail library, Internet, computational facilities at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik.
12. A Research technologist or Scientist associated with BRC may be appointed a Co - project guide as per the rules of the respective institute for a student in last year of degree at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik. The student may be encouraged to take up the project such that BRC desirably benefits from its outcomes provided BRC will guide for the same.
13. The students will carry out part of their project / research work at K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik and BRC depending on the nature of the work as per rules of the respective institute depending on facilities and requirements.
14. There will be no restriction on the contents of the project / thesis and on publication of results of the project / thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work, which will be decided with mutual consent.
15. Both K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik and BRC will be free to independently carry out follow- up project / research on the thesis work conducted under this scheme.

#### ARTICLE-III : SHARING OF FACILITIES

1. K.R.T.Arts, B.H.Commerce and A. M. Science College, Nashik shall make provisions to share their respective laboratory and important R&D facilities while BRC will provide research implementation platform at Fruit and food Processing and applied areas in order to promote academic and research interaction, project, courses and in plant training for students.

#### ARTICLE-IV : EFFECTIVE DATE AND DURATION OF MOU

1. This MOU shall be effective from the date of its approval by competent authorities at both ends.
2. The duration of the MOU shall be for a period of **3** years from the effective date.
3. During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students / faculty / scientists who have been admitted to pursue a program under the MOU.
4. Any clause or article of the MOU may be modified or amended by mutual agreement of K.R.T.Arts, B.H. Commerce and A. M. Science College, Nashik and BRC.

#### ARTICLE-V: CONFIDENTIALITY



CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions.

#### ARTICLE-VII: RESOLUTION OF DISPUTES


1. This agreement shall take effect and be constructed in accordance with the Laws of India and be subject to the jurisdiction of the courts at Nashik.

The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be New Delhi and Language of arbitration shall be English.

1. The headings and sub-headings are inserted for convenience only and shall not affect the construction of this Agreement.
2. Both K.R.T. Arts, B.H.Commerce and A. M. Science College, Nashik and BRC shall not, during the term of this Agreement directly or indirectly, solicit or offer employment or engagement to any of the personnel of other party without the prior consent in writing of that other party.
3. The rights, remedies, power and privileges herein provided are cumulative and not exclusive of any right, remedies, powers and privileges provided by law.
