



MEMORANDUM OF UNDERSTANDING



KRT Arts, BH Commerce & AM Science (KTHM) College,

Nashik, Maharashtra

&



Creative Electronics, Nashik



This Memorandum of Understanding (“MOU”) is made this 5th day of July 2022 (Tuesday) (“**Effective Date**’) **BETWEEN:**

- (1) **KRT Arts, BH Commerce & AM Science (KTHM) College**, Shivaji Nagar, Gangapur Road, Nashik a educational institute affiliated to Savitribai Phule Pune University working at Nashik District of Maharashtra, India, 422002. (Herein after referred as “**KTHM College**” (**Party –I**) which expression shall, where the context so permits, shall include its successors in title and permitted assigns)
- (2) **Creative Electronics Institute** Nashik District of Maharashtra, India. Here in after referred as (**Party-II**)
- (3) The aforesaid institutions are here in after referred as party I & party II.

KTHM College and **Creative Electronics Institute, Nashik** shall hereinafter together be referred to as the “**Parties**” and the term “**Party**” shall be construed accordingly.

- A. KTHM College is well known higher educational institution in Nashik district established in 1969 and enjoy the privilege of being K.R.T. Arts, B.H. Commerce and A.M. Science College, Nashik (popularly known as KTHM College) established in 1969 and enjoys the privilege of being one of the best colleges affiliated to Savitribai Phule Pune University with consistently outstanding performance record. The college is spread majestically in 37 acres and is situated on the bank of river Godavari in a serene atmosphere which is ideally suited for the pursuit of Higher Education and Research.
- B. Creative Electronics Institute Nashik established in the year 2014 in a Nashik.
- C. The parties are desirous of entering into this Memorandum of Understanding (**MOU**) to facilitate implementation of the partnership and for related purposes upon the terms and conditions hereinafter contained.



SCOPE OF THE MEMORANDUM:

This memorandum sets forth the ground for collaboration / educational partnership between KTHM college and Creative Electronics Institute Nashik-2 and offering and conducting training programs on Arduino-based projects, robotics, and industrial Automation as a central facility in the area of Electronics, on job training (OJT) and internship for PG students.

OBJECTIVES OF MOU

- The goal is to foster collaboration, provide opportunities for global experience, and facilitate the advancement of knowledge based on reciprocity, best effort, mutual benefit, and frequent interactions.
- 1. To exchange information on research and educational programs
- 2. To exchange information on teaching, learning material, and other literature relevant to their educational and research programs.
- 3. To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein
- 4. To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- 5. To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- 6. To exchange, on a reciprocal basis, students at Undergraduate and Graduate levels for limited periods for purpose of education.

Both colleges further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.



NOW IT IS AGREED as follows:

1. MUTUAL COOPERATION

The partnership will be conducted in a spirit of mutual benefits and fairness and the parties agree that they will use their utmost goodwill and reasonable efforts to fulfil their respective obligations set out herein.

2. AREAS OF COLLABORATION

Both Parties will collaborate in the following areas:-

- 2.1 Party I will design course / curriculum with the help of Party II as per the requirement of Party II.
- 2.2 Party II will update the curriculum as per need periodically in consultation with Party I.
- 2.3 Party I will assist in improvement of skill designed of teaching to Party II.
- 2.4 Both Parties will coordinate to organize necessary workshops, conferences & personality development programmes either on the site of Party I or Party II.
- 2.5 Party I will help Party II to conduct training of the students admitted for the course by experts in the field.
- 2.6 Both the parties will jointly supervise the programme.
- 2.7 Party II will coordinate with the Party I for the skill develop in the specialized area.
- 2.8 Both parties will be committed on recruiting students.

3. Responsibilities of the KTHM and Creative Electronics Institute, Nashik.

Both Parties will have to follow below mentioned terms & conditions:-

- 3.1 The KTHM (Party I) will make arrangement for classroom, teaching material, computer lab, internet connection and teaching aids like projector , white board, markers, etc. The KTHM and Creative electronics institute, Nashik jointly fulfill the required training equipment /instruments for conduction of proposed OJT and courses. This activity will utilize the lab equipment's / instrument's for skill enhancement and capacity building of students.
- 3.2 Creative electronics institute, Nashik (Party II) will provide adequate laboratory / workshop facilities for face to face delivery of skills and hands on practice for Students.



- 3.3 Party I and II in collaboration will arrange training programs (Annexure-I) wherever required for imparting necessary skills to students either at site of Party I or Party II.
- 3.4 The cost of organization of workshop, training, conferences personality development programme will be borne by host institute.
- 3.5 The cost of the operative system including transportation, field visit, preparation material, rough material for training , internship, web creation, hiring services, meeting etc., will be borne by host institute.
- 3.6 Both the parties will be responsible for time bound achievement of the completion of syllabus and for its progress, monitor periodically.
- 3.7 The admission of students will be done by Party I.
- 3.8 Responsibility of teaching syllabus will be taken up by Party I.
- 3.9 Party I will conduct examination, evaluation of the students and declare result.
- 3.10 This MOU may be amended, renewed & terminated by mutual written agreement.

4. PAYMENT

Any monetary considerations/claims Creative Electronics Institute Nashik should coordinate with KTHM.

5. DURATION AND TERMINATION

- 5.1 This MOU is effective upon the date it is executed by the duly authorized representatives of the parties to this MOU, for a term of five years (60 months) and shall terminate upon completion of the agreed upon term.
- 5.2 Each Partner shall have the right to terminate this Agreement at any time if it determines that in its opinion, reasonably held, the other Partner has failed to honour its obligations arising from this MOU in a material manner.

6. CONFIDENTIALITY








