CLAUSE 4

VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually Agreed terms, during which period, the Second Party **ISHWARI ENTERPRISES**, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Training Partner or **ISHWARI ENTERPRISES**, the Second Party after termination of this Agreement by way of communication, correspondence etc. shall not be construed as an extension of this MOU.

Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **Nashik**.


