Objectives of MOU

The objectives of the MOU are:

- To promote research/continuing education activities between SIDDHARTH MUSHROOM, Nashik and KTHM, Nashik.

Technical Areas of Collaboration:

- A continuing quality improvement program to improve quality of teaching.
- Provide academic interaction and enhancement of skills of students through delivering special lectures and organizing workshops/conferences and personality development programmes.
- Usage of academic infrastructure of industry and college for students and faculty members.
- To facilitate the training for students.
- Guidance for enhancement in infrastructure development

Proposed Modes of Collaboration

SIDDHARTH MUSHROOM, Nashik and KTHM, Nashik propose to collaborate through the following:

- Corporation and promotion of education, research and training in areas of mutual interest.
- Any other appropriate mode of interaction agreed upon between colleges.

Duration of MOU:

This MOU, unless extended by mutual written consent of the industry and colleges, shall expire in FIVE years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another THREE years by mutual consent.
