1. OBJECTIVE

2.3-Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of business without consent of both parties.

2.4- Termination of MOU: Either party shall have the right to terminate the MOU any time prior to expiration of its initial term of ____ by providing termination notice of 30 days. In event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

2.5-Extension of Agreement: The MOU may be extended provided the parties agree upon, and can provide the necessary resources.

2.6-Communication: All notices, demands and other communication under this agreement in connection herewith shall be written in English Language and shall be sent/mailed to the appointed person(s) of the concerned party.

2.7- The agreement is signed to jointly develop a curriculum that is tailored to the requirements of present Screen-Printing Industry as well as international training standards.

2.8- Through this collaboration, NIPUN HR SOLUTIONS is taking an important step towards improving the training of prospective Screen-Printing Engineers and teaching staff.
