



# Memorandum of Understanding (MoU)

Between

**Om Intelligence, Nashik**

(Hereinafter referred to as "Om Intelligence")

**AND**

**MVP Samaj's K.R.T. Arts, B.H. Commerce and A.M. Science (K.T.H.M.) College, Nashik**

(Hereinafter referred to as "the College")

## I. PREAMBLE

This Memorandum of Understanding (MOU), effective as of 15-September-2023, is entered into by Om Intelligence ("Om Intel") and the College. This agreement aims to establish a cooperative partnership to foster educational enrichment and practical experience for students in the fields of artificial intelligence (AI), blockchain technology, augmented reality (AR), virtual reality (VR), CTO-level skills, and other emerging technological fields.

## II. SCOPE OF COLLABORATION

### **Purpose:**

The purpose of this MOU is to formalize a framework for collaboration between Om Intelligence and the College. This partnership seeks to enhance the technological skill sets of students and faculty, facilitating a rapid up skilling process that significantly reduces the time required for learning and development in emerging technologies.

## III. RESPONSIBILITIES

### **Om Intelligence's Responsibilities:**

- **Educational Resources and Mentorship:** Om Intelligence will provide comprehensive educational resources, lectures, and access to proprietary tools in the field of logging and



AI. These resources are designed to supplement the students' educational journey in technology.

- **Mentorship and Industry Insights:** Team members from Om Intel will offer mentorship and share industry insights, addressing queries related to technology and enhancing the overall learning experience.
- **Internship Opportunities:** Om Intel will offer various one-month part-time internships (online+offline) as research analysts in AI. For students with a keen interest in programming, coding-based internships across multiple technologies will be available. Successful completion of the initial one-month period may lead to an offer of a longer-term internship. Although these internships are unpaid, participants will receive an internship experience certificate

#### **College's Responsibilities:**

- **Engagement and Promotion:** The College will engage students in this collaborative initiative, ensuring wide participation and promoting the educational resources provided by Om Intel, with a focus on nurturing skills in AI, blockchain, and designing and CTO-related technologies.
- **Enrollment and Support:** The College will assist interested students in accessing the educational offerings from Om Intel and provide necessary support throughout the enrollment process.
- **Student Selection for Internships:** The College will recommend students for internships based on eligibility criteria, focusing on those who demonstrate a strong interest and aptitude in the targeted technology fields.
- **Faculty Development Programs (FDPs):** The College will organize FDP-like programs in collaboration with Om Intelligence, aiming to accelerate the upskilling of faculty members in the aforementioned technologies.

#### **IV. INITIAL ACTION**

**Student Engagement:** As a first activity under this MoU, all interested students shall fill a Google form, so they can be properly on boarded to Om Intelligence's education initiatives. This will set the tone for application for the further 1 month AI internship.



**V. IMPACT ACCELERATED EVOLUTION:** This collaboration is designed to significantly expedite the learning curve for both students and faculty, potentially reducing the time required to acquire new skills by a factor of 10x or more. This accelerated evolution aims to prepare participants for the rapidly changing technological landscape.

#### VI. ADDITIONAL PROVISIONS

**Duration:** This MOU is valid for a period of five years from the effective date and is subject to renewal upon mutual agreement.

**Termination:** Either party may terminate this MOU with *specify notice period* notice under conditions agreed upon by both parties.

**Confidentiality:** Both parties agree to maintain the confidentiality of any sensitive information shared during the collaboration, unless required by law to disclose such information.




