

## Memorandum of Understanding



This memorandum of understanding is made and executed at Nashik on 15<sup>th</sup> day of November 2022.

### **1. BACKGROUND**

The **Party of the FIRST PART** was established in the year 1969, by the Maratha Vidya Prasarak Sama's Nashik. It is affiliated to the Savitribai Phule Pune University, Pune and recognized by the Government of Maharashtra.

### 3. PURPOSE

The purpose of this Memorandum of Understanding is to establish a framework for co-operation between **Party of the FIRST PART** and **Party of the SECOND PART** to conduct the tally program courses at KTHM campus. The parties now, have therefore, agreed to sign Memorandum of Understanding. The Memorandum of Understanding will be applicable for the period of One Academic Year only.



### 4. RESPONSIBILITIES

**4.1 Training Program and syllabus:** The **Party of the SECOND PART** shall offer the following training program as approved by the **Party of the FIRST PART**.

**4.2 Fees Revenue Sharing:** Fees will be shared in the ratio of 84% (CCA) and 16% (KTHM College).

**4.3 Handouts and Certificates:** The cost of handouts and Certificates to be distributed and given to trainees is included in the Fees as decided in clause 4.1. The **Party of the SECOND PART** shall not distribute the Handouts and Certificates without prior permission of the **Party of the FIRST PART** the cost of printing certificate, study material, handouts should be bear by **Party of Second Part**.

**4.4 Training Schedule and Duration:** The schedule of the training batches will be decided as per mutual consent and availability of computer lab.

**4.5 Administrative and Infrastructural Support:** The **Party of the FIRST PART** shall provide training room, suitable to the number of trainees to conduct training program along with Computer Lab, Projector with screen, Audio file players, and Helpdesk counter for counselling the students.

**4.6 Teaching Staff:** The trainer will be our professional certified and will be provided by part of the second part. The trainer's remuneration convenience will be paid by party of the second part. The trainer will not be employed by KTHM











4.7 Faculty will be provided By **Party of the SECOND PART** and their remuneration will be paid by **Party of the SECOND PART**.
